School Facility Conditions and Planned Improvements (School Year 2011-12)

Vallecitos School provides a safe and clean school environment for students and staff. Our campus continues to be virtually free of vandalism and other crimes, enhanced by an updated digital camera surveillance system. Our maintenance staff performs basic cleaning operations in every classroom. Safety drills are held on a regular basis. In 1994, the permanent school buildings were fully renovated. Its current population of roughly 219 students in grades PK-8th is buttressed by nine portable classroom buildings, which were erected to house the increased student enrollment and new programs implemented. The playfields and recreational equipment was also upgraded. There remains a critical need for a multi-purpose room to serve the needs of the current student population. Currently 13 teachers (including a Title I teacher, resource specialist, and speech therapist) serve the needs of our

community.

Types of Services Funded (Fiscal Year 2010–11)

The Vallecitos School District had implemented a reading/language arts program in grades K-5 titled, Rainbow's Reading, which has proven to be highly effective as measured by district standards, portfolios and the annual state assessment. The program won the distinguished Golden Bell Award from the California School Boards Association in 1998 for its proven track record of increasing academic achievement for all students. A cumulative language arts portfolio has been developed by the Vallecitos staff to complement the developmental reading stages in the new reading program that has been adopted by a number of other school districts in San Diego County. The district teaches the California's content standards in language arts, mathematics, science, and history in grades K-8. In addition to our regular education program, the Vallecitos Elementary School District offers the following high quality support services:

Psychological Services: A psychologist is assigned to the school one day per week. The Psychologist provides assessment services on an individual basis and emergency counseling as necessary.

Resource Specialist Teacher: The school has a full-time resource specialist who works directly with students

qualifying for special education services, and who acts as a resource to the classroom teacher.

Speech/Language Specialist: A part-time specialist services preschool children and students in grades K-8. The focus is on language development and articulation.

Migrant Education: Students who qualify for Migrant Education services receive additional time and support in any academic content area from a part-time instructional aide.

Club Viking After School Program: Roughly sixty students participate in our after Club Viking Program, which is free to qualifying families. The program offers the instruction in the following four areas: Character Education, Enrichment, Academic Intervention Services, and Physical Education.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- **California Standards Tests (CSTs)**, which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- **California Modified Assessment (CMA)**, an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- **California Alternate Performance Assessment (CAPA)**, includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

University of California

Admission requirements for the University of California (UC) follow guidelines set forth in the Master Plan, which requires that the top one-eighth of the state's high school graduates, as well

as those transfer students who have successfully completed specified college course work, be eligible for admission to the UC. These requirements are designed to ensure that all eligible students are adequately prepared for University-level work.

Eligibility for admission to the California State University (CSU) is determined by three factors:

- Specific high school courses
- Grades in specified courses and test scores
- Graduation from high school

Some campuses have higher standards for particular majors or students who live outside the local campus area. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region.
